Jackson's costs to serve this EDR customer are reflected in the monthly power invoices received from EKPC. Thus, the Net Demand Cost from EKPC equals EKPC's Rate C demand charges net of interruptible service demand credits and the EDR credit. The Energy Cost from EKPC equals EKPC's Rate C energy charges plus the EKPC FAC.

The marginal costs to serve this customer are reported by EKPC in its annual EDR report; please see the current EKPC EDR report for information related to Big Sur Group, Inc.
