# MOTION OF SENTRA CORPORATION FOR LEAVE TO WITHDRAW APPLICATION

Sentra Corporation ("Sentra"), by counsel, moves the Kentucky Public Service

Commission ("Commission") for leave to withdraw its Application For Approval of Special

Contract. In support of its motion, Sentra states as follows:

- 1) On October 25, 2022, Sentra filed its Application for Authorization to Enter into a Special Contract with Indian Creek Farm. The actions taken in this case to date are the Commission's entry of its November 10, 2022 Order setting a procedural schedule and suspending Sentra's proposed contract with Indian Creek Farm for 5 months, and Commission Staff's service of Staff's First Request for Information to Sentra on November 23, 2022. Sentra's Answers to the First Request for Information are to be filed on December 21, 2022. There are no intervening parties in this case, and no pending motions to intervene.
- 2) Indian Creek Farm, a current customer of Sentra, operates a contract poultry broiler operation. Sentra's Application was filed due to its concern that it would lose its poultry customers, including Indian Creek Farms, because of the difference between the price of propane gas, which is available to poultry customers, and the cost of natural gas.
- 3) Sentra has determined, after conversations with poultry customers in recent weeks, and monitoring the price of propane, that it will continue to use its existing rate that was determined to be fair, just and reasonable in Case No. 2020-00102 when selling natural gas to its

4) Sentra hereby requests the Commission for leave to withdraw its Application filed in this case, and for the Commission to hold that it is not required to answer Commission Staff's First Request for Information.
