- A-2(a). Since January 1, 2022, **Beech Grove Water System** has received 24 locate line requests.
- A-2(b). Since January 1, 2022, **Beech Grove Water System** has received 3 second or subsequent requests.
- A-2(c). 3 to 4 business days
- A-2(d). N/A
- A-2(e). All locate requests have been performed by the utility's personnel.
- A-2(f). Specific records are not kept referencing accurate versus inaccurate location of Beech Grove Water System infrastructure. However, nothing was damaged in 2022.
- A-2(g). The operator ensures lines are marked correctly by using maps, line locator, probing method and knowledge of the technician.
