Comes now the Harrison County Water Association, Inc., (HCWA), by and through their president of the board of directors, Mr. J. Frank Marsh, and the manager, Mr. Nathan Fields, and through counsel, Mr. Jesse P. Melcher, Esq. and make the following responses to the Kentucky Public Service Commission's (PSC) Order herein, regarding locates of utility property.

As grounds for this request, the Harrison County Water Association, Inc. does hereby establish as follows:

- a. Since January 1, 2022, the number of locate requests received in total and broken out into the types of locate requests contained in KRS 367.4909(5);

Response: HCWA has had since January 1, 2023 to November 30, 2022, (the time frame of answering these questions), a total of 1244 water utility locates, pursuant to KRS. 3674909.

A break down of the total locates, as identified by the subcategories of locates under KRS 367.4909(5) is as follows:

- a) Normal Excavation locate requests:
response: 1204
- b) Emergency locate requests:
response: 35
- c) Design information requests:
response: 5
- d) Large project requests:
response: None.

e) Unmapped or untonable locates:

response: None

f) Fiber to premises broadband locates:

response: none, HCWA only utility involved is water.

b. Since January 1, 2022, the number of second or subsequent requests for the same locate request received in total and broken out into the types of locate requests contained in KRS 367.4909(5);

Response: none/0

c. Since January 1, 2022, the length of time required to respond to each requestor / excavator in total and broken out into the types of locate requests contained in KRS 367.4909(5). Response: All were completed (for all subcategories) in less than 2 days. Average time of locate for all responses would be less than 2 days and/or 48 hours, exclusive of holidays and weekends.

- d. Since January 1, 2022, the number of times an agreement has been reached with an excavator outside of the statutory time limits required by KRS 367.4909 with the aggregate numbers and broken out into the types of locate requests contained in KRS 367.4909(5);

Response: None for all subcategories of KRS 367.4909(5).

- e. Since January 1, 2022, state whether locate requests have been performed by Utility personnel or by a third-party contractor. If the answer is both, provide the number of locate requests performed by Utility personnel and third-party contractors, respectively:

Response: All water locates have been performed by the Harrison County Water Association, by their employees.

- f. State whether records and statistics are kept of the number of underground facilities located accurately versus inaccurately. Provide all records and statistics compiled since January 1, 2022:

Response: No permanent records are kept as a usual course of business; temporary records are kept around the time of the requested locate to year and maintained by saved Excel Worksheet HCWA had a total of 1244 locates performed with 1 line being hit. See attached records of excel spread sheet, identified as Exhibit "A", which is full incorporated herein.

- g. Explain the method used to determine whether an underground facility has been located accurately versus inaccurately:

Response: HCWA maintains an updated GPS/GIS system of its entire distribution system, and the water locates are based upon the GPS/GIS markings and/or readings, which can be double checked, by tonable locates, via tracer wire on the lines, wherein, the area is marked within three (3) feet of center of line, with blue flags placed along the marked approximate center line.

HCWA assumes If the water main is not hit, the locate was made accurately, and if the line was hit, rechecks the markings to determine if the marking was in error or the contractor/excavator erred in reading and/or interpreting the line markings.

- h. State what policies and procedures have been implemented to reduce the number of inaccurately located facilities. Provide information detailing the efficacy of those procedures on reducing the number of inaccurately located underground facilities.


Response: Harrison County Water Association uses GIS mapping, tracer wire on all new mains and service lines, as well as record as-built drawings of mains. We are a member of 811. All locating is performed in house to achieve maximum accuracy.
