AFFIDAVIT OF KENNETH TAYLOR

I, Kenneth Taylor, having been first duly sworn, depose and state as follows:

- (1) My name is Kenneth Taylor. I am the Senior Project Engineer with Kenvirons, Inc. (“Kenvirons”), 770 Wilkinson Boulevard, Frankfort, Kentucky 40601.
- (2) I have never been an employee, contract employee or customer of Cumberland Falls Highway Water District (CFHWD). My association with CFHWD has been entirely as an employee of the engineering firm Kenvirons. Kenvirons has served as CFHWD’s primary engineering consultant since 1996. I have functioned as Kenvirons’ primary contact person (project engineer) with CFHWD since 2015 upon the retirement of Mr. Carlos Miller from the firm.
- (3) I have served as the project engineer on the following projects directly for CFHWD:

 - b. Oakdale Estates and E&E Anchor Estates Waterline Extensions (Ken Wilson Engineering).


