CMAR PRO HAC VICE**


Come Joint Intervenors, Kentuckians for the Commonwealth, Kentucky Solar Energy Society, Mountain Association, and the Kentucky Resources Council, Inc., by and through counsel, hereby provide notice of filing of the attached corrected invoice associated with the Motion of April 10, 2023 to Admit Thomas Cmar Pro Hac Vice.

In the Commission’s Order of April 26, 2023, it was directed that “Joint Intervenors shall file proof that Hema Lochan, and Thomas Cmar have been certified to practice before the Commission in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2) within ten days of service of this Order.”

The Kentucky Bar Association does not provide a separate certification form, but instead includes at the bottom of the payment receipt a comment indicating the payment of the fee, the person making that payment, and the case for which the payment and out-of-state counsel certification is provided. Proof regarding Ms. Lochlan’s certification was attached to Joint Intervenor’s Motion of April 10, 2023 to admit her Pro Hac Vice; however, the receipt attached to the motion to admit Mr. Cmar lacked that comment. The corrected invoice is attached, confirming payment of \$317.75 for Mr. Cmar, pursuant to Kentucky Supreme Court Rule 3.030, contains a comment that “The Kentucky Bar Association certifies that Thomas Cmar has paid the


