Donations typically drop in summer while need remains consistent

LEXINGTON, Ky. — Between warm-weather activities, family vacations and no school, summer is an exciting time of the year. For those very same reasons, it's also a tough season on the blood supply. To ensure summer is a safe and enjoyable time for everyone, Kentucky Blood Center is urging donors to be proactive this summer and donate blood.



All donors at this KBC drive will receive a limited-edition "Give Back, Give Blood" T-shirt (while supplies last) as a thank you for donating.

Donation numbers historically dwindle during summer, but the need for blood doesn't take a vacation. Donations at KBC in 2022 were down more than 12 percent from 2019, the last summer before the COVID-19 pandemic. 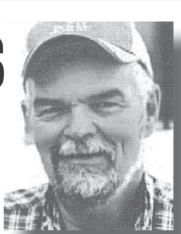





(1) In accordance with KRS 350.055, notice is hereby given that Sterling Ventures, LLC, 376 South Broadway, Lexington, KY 40508, intends to apply for an amendment/revision to an existing non-coal surface mining permit for a limestone mining and processing operation doing business as Sterling Materials Sierra One. The original permit covers 98.82 surface acres and 916.37 underground acres. The amendment will add 34.0 acres of surface area and the revision will modify the sediment control plan.

(2) The entrance to the site is located approximately 2,600 feet west of the intersection of Hance Road and U.S. 421 in Gallatin County. Kentucky Division of Forestry: Wildfire at Natural Bridge State Resort Park contained

It burned through 125 acres, spread into Daniel Boone National Forest

The wildfire at Natural Bridge State Resort Park in Slade, Kentucky, is 100% contained, the state's Division of Forestry said Monday.

The fire, which started April 17, burned through 125 acres and spread into the Daniel Boone National Forest, according to a joint press release from the U.S. Department of Agriculture and Kentucky State Parks. A crew with the Kentucky Division of Forestry planned to remain at the park Monday and Tuesday to monitor the containment, it said on Facebook.

The burn ban in Warren County, Kentucky, which went into effect April 20, has also been lifted.

In a Facebook post, the Powell County Tourism Commission said trails at the park will remain closed until further notice. However, local businesses and all trails at Red River Gorge, which is less than 20 miles east, are open.

The cause of the fire remains under investigation, the USDA and Kentucky State Parks said.

Responders with the Kentucky Division of Forestry, U.S. Forest Service, Daniel Boone National Forest and local fire departments worked together to contain the burn and clean up the site. A red flag warning, which indicates a heightened risk of fire danger, was in place in the area Thursday.

Records: Cincinnati police officer arrested, faces OVI charge in Clermont County

A Cincinnati police officer was arrested earlier this month on a drunk driving charge, according to court documents.

Justin Shields, 25, of College Hill is charged with OVI and speeding after an Ohio State Highway Patrol trooper pulled him over on April 14.

Shields' police powers have been stripped and he is on administrative duties pending the outcome of his court proceedings, Cincinnati police reported.

According to his ticket, Shields was driving his 2014 Infiniti on Interstate 275 in Union Township just before 1 a.m. that Friday. The trooper reported Shields was going 80 mph in a 65 mph zone and refused a breathalyzer test.

Shields pleaded not guilty to the charges on April 20. His next court date is scheduled for Thursday.

City records show Shields was hired in 2021 and makes just over \$74,000 annually. He was commended in December for his work during the city's two-week "traffic blitz" focused on dangerous driving and at that time was assigned to District 3, which covers Cincinnati's West Side.
