REQUEST NO. 1.

Provide documents sufficient to show the pole height and corresponding investment for each one of the 71 poles identified by Bruce Sailer in his rebuttal testimony as poles that were “unitized during the year 2022 but were not unitized as of 12/31/2021.” *See* Sailer Rebuttal Testimony at 14:3-6.

Provide any documents related to Duke's construction guidelines for 50-foot poles, including all diagrams, guidelines, and other documents illustrating Duke's safety space, clearance, usable space, and below ground requirements.
