**Kentucky Power Company’s Motion to Amend Procedural Schedule**

Kentucky Power Company (“Kentucky Power” or the “Company”) respectfully moves the Public Service Commission (“Commission”) to issue an order **on or before May 29, 2023** amending the procedural schedule in this proceeding, particularly to reschedule the June 21, 2023 hearing date established by the Commission’s May 19, 2023 Order issued in this proceeding. Good cause exists to reschedule the hearing for a date between July 11-14, 2023 or July 17-21, 2023, or a date thereafter that is convenient to the Commission.

One of the Company’s witnesses will be out of the country and unavailable to testify for the entire week of June 19-23, 2023. As such, good cause exists to reschedule the hearing date from June 21, 2023.

In addition, the Company plans to file on June 29, 2023 its base rate adjustment application in Case No. 2023-00159. The same people and resources involved in preparing this base rate adjustment application are witnesses or counsel that will be required to prepare for and appear at a hearing in this matter, which would leave those resources overly-strained in their efforts to prepare and file a robust and timely base rate adjustment application, and adequately prepare for hearing. Thus, the Company respectfully requests that if the Commission reschedules the hearing, that it not be rescheduled during the week of June 26-30, 2023.

All Company witnesses and counsel will be available to appear at a hearing in this matter between July 11-14, 2023 or July 17-21, 2023. Thus, good cause exists to reschedule the hearing in this matter for a date between July 11-14, 2023 or July 17-21, 2023, or a date thereafter that is convenient to the Commission.

Finally, the Company requests the Commission to issue its order on or before May 29, 2023, so that the Company would have the necessary time to prepare the newspaper notice required by 807 KAR 5:001, Section 9(2), and timely transmit the same to Kentucky Press Service, should the hearing remain scheduled for June 21, 2023.

WHEREFORE, Kentucky Power Company respectfully requests the Commission to enter an Order on or before May 29, 2023:

1. Amending the procedural schedule in this proceeding and rescheduling the June 21, 2023 hearing to any date convenient for the Commission between July 11-14, 2023 or July 17-21, 2023, or a date thereafter that is convenient to the Commission; and
2. Granting Kentucky Power all further relief to which it may be entitled.
