**DUKE ENERGY KENTUCKY, INC.’S
ANNUAL REPORT FOR 2023**

I. Introduction

On May 8, 2023, the Kentucky Public Service Commission (Commission) issued an Order¹ concluding its review of Duke Energy Kentucky, Inc.’s (Duke Energy Kentucky or Company) Economic Development Incentive Service Agreement with Diversey, Inc. (Diversey). The Commission found that the terms of the agreement were reasonable and subsequently approved the Agreement between the Company and Diversey. However, Paragraph 4 of the Order states:

*By March 31 of each year, Duke Kentucky shall file an annual report with the Commission detailing, for the prior calendar year, revenues received from Diversey and the marginal costs associated with serving Diversey throughout the term of the special contract.*²

Further, Paragraph 6 of the Order states:

*Duke Kentucky shall file by March 31 of each year a report with the Commission providing, for the prior calendar year, the information shown in the Appendix to this Order.*³
