1. Change p. 23, lines 323 and 324 to “PJM membership today would confer a 16 percentage point reduction in the relevant reserve margin,” from “20 percentage point.”
2. Change p. 32, table 4, footnote 10 to “Total UCAP minus [6] x (1+PRM) / FPR,” adding the term “1+” before PRM, to reflect the calculation correctly performed in the table.
