SECOND SUPPLEMENTAL ERRATA FILING

Kentucky Utilities Company and Louisville Gas and Electric Company (collectively, "Companies"), by counsel, hereby give notice of the following corrections to Exhibit SB4-1 to the Direct Testimony of Stuart A. Wilson in Case No. 2023-00122.¹

- 1. Page 20, Table 8: Portfolio 1 in Table 8 incorrectly included \$38 million (2027 dollars) of transmission system upgrade cost, which would not be required in that portfolio because Brown 3 and Ghent 2 were not retired without replacement (which would have necessitated the additional transmission cost). The corrections shown for Portfolio 2 are to adjust for the changes to Portfolio 1. Note that the cumulative change shown in the "Cumulative vs. Portfolio 0" does not change in Portfolio 2.
- 2. Page 26, Table 11: The column headings "Cooling Tower" and "ELG" under "Mill Creek 1" were reversed. The attached changes correct this mislabeling.
