Reference is made to the Transportation Agreement (Agreement) dated December 10, 2012, between Texas Gas Transmission, LLC (Texas Gas) and Kentucky Utilities Company (Customer) providing for the transportation of natural gas by Texas Gas for Customer.

Accordingly, Texas Gas and Customer hereby desire to amend the Agreement between them as follows:

1. Effective upon the execution of this amendment:
  - A. Term: This Agreement shall be effective April 1, 2015 and shall continue in full force and effect through October 31, 2024.
  2. Effective each Summer Season beginning April 1, 2020 through October 31, 2024:
    - A. The Contract Demand(s) for this Agreement shall be: 44,000 MMBtu per day.
    - B. Exhibit A, Primary Point(s) Receipt, shall be deleted in its entirety and replaced with the attached Exhibit A, Primary Point(s) Receipt.
    - C. Exhibit A, Primary Point(s) Delivery, shall be deleted in its entirety and replaced with the attached Exhibit A, Primary Point(s) Delivery.

This amendment shall continue in full force and effect through the term of the Agreement.

The operation of the provisions of this amendment shall be subject to all applicable governmental statutes and all applicable and lawful orders, rules, and regulations.
