COMPLIANCE WITH 807 KAR 5:076, SECTION 5

In accordance with 807 KAR 5:075 Section 5(2)(b), Bath County Water District has caused the notice on the next page to be published in a prominent manner in the *Bath County News Outlook*, a newspaper of general circulation in Bath County Water District's service area, once a week for three (3) consecutive weeks, beginning December 15, 2022.

In accordance with 807 KAR 5:076, Section 5(1)(a), Bath County Water District has posted at its office a copy of the notice on the next page as of December 15, 2022.

As of December 15, 2022, in accordance with 807 KAR 5:076, Section 5(1)(b), Bath County Water District has posted on its website a copy of the notice on the next page and a hyperlink to the location on the Public Service Commission's website where the case documents are available.

NOTICE

The Kentucky Public Service Commission has ordered the Bath County Water District to file a rate adjustment application in Case No. 2022-00067 on December 31, 2022. To comply with this Order, on or about **December 31, 2022** Bath County Water District will file an application with the Kentucky Public Service Commission for the purpose of adjusting its monthly rates for water service. This application will be filed pursuant to the procedures set forth in 807 KAR 5:076. Under those procedures, the proposed rates may not be placed into effect until the Kentucky Public Service Commission has issued an order approving the proposed rates or six (6) months from the date of the filing of the application, whichever occurs first.

The rates contained in this notice are the rates proposed by Bath County Water District. However, the Kentucky Public Service Commission may order rates to be charged that differ from the proposed rates. Such action may result in rates for consumers other than the rates in this notice.

A person may submit a timely written request for intervention to the Kentucky Public Service Commission, P.O. Box 615, Frankfort, Kentucky 40602, establishing the grounds for the request including the person's status and interest. If the Kentucky Public Service Commission does not receive a written request for intervention within thirty (30) days of the initial publication of notice, it may take final action on the proposed rates.
