**CLOVER CREEK SOLAR PROJECT LLC'S**  
**NOTICE OF WITHDRAWAL OF NOTICE OF INTENT**

Comes now Clover Creek Solar Project LLC d/b/a New Frontiers Solar Park (“Clover Creek”), by and through counsel, hereby tenders its Withdrawal of Notice of Intent for a certificate to construct an approximately 100 megawatt (“MW”) merchant solar electric generating facility and nonregulated electric transmission line in Breckinridge County, Kentucky, respectfully stating as follows:

1. On November 23, 2022, Clover Creek filed an initial Notice of Election to Use Electronic Filing Procedures related to the planned filing of an application for a construction certificate with the Kentucky State Board on Electrical Generation and Transmission Siting (the “Siting Board”) to be filed on or before March 1, 2023.
2. On November 29, 2022, Clover Creek submitted its formal Notice of Intent, pursuant 807 KAR 5:110, Section 2, stating that the application for a construction certificate would be filed on or before March 1, 2023. This notice was supplemented by a Notice Regarding Anticipated Application Filing Date dated February 28, 2023, which served to notify the Siting Board of Clover Creek’s intent to file its application on or before May 29, 2023.

3. Clover Creek has determined that it is currently infeasible to file the referenced application and hereby provides notice to the siting Board of its withdrawal of its Notice of Intent.

4. It is Clover Creek's intent to initiate a new application when conditions have improved. Until then, Clover Creek recommends closing this matter and removing it from the Siting Board's docket.
