## **VERIFIED APPLICATION**

Hardin County Water District No. 1 ("Hardin District") applies to the Public Service Commission ("Commission") for an order declaring, pursuant to 807 KAR 5:001, Section 19, that Hardin District is eligible to use the procedures set forth in 807 KAR 5:076 to apply for an adjustment of the rates of its Radcliff Wastewater System for sewer service, or in the alternative, granting a deviation from 807 KAR 5:076 pursuant to 807 KAR 5:076, Section 17, to permit Hardin District to apply for an adjustment of the rates of its Radcliff Wastewater of its Radcliff Wastewater System using the procedures set forth in 807 KAR 5:076. Hardin District requests that the Commission render a decision on this Application no later than **February 15, 2023**.

In support of its Application,<sup>1</sup> Hardin District provides the following:

# A. Background

1. The full name and post office address of Hardin District is: Hardin County Water District No. 1, 1400 Rogersville Road, Radcliff, Kentucky 40160. Its e-mail address is: shogan@hcwd.com.

3. Hardin District is not a corporation, limited liability company or limited partnership. It has no articles of incorporation or partnership agreements.

4. Hardin District is a water district created under the provisions of KRS Chapter 74 and is a political subdivision of the Commonwealth of Kentucky.

5. Hardin County Court created Hardin District pursuant to an order entered August 20, 1952. A copy of this Order and subsequent Orders modifying Hardin District's territory are attached as **Exhibit 1** to this Application.

6. Hardin District owns and operates facilities that provide, as of December 31, 2021, retail water service to approximately 10,395 customers in Hardin County, Kentucky, and wholesale water service to Meade County Water District and the cities of Vine Grove, Hardinsburg, and West Point.<sup>2</sup> It also owns and operates facilities that provide, as of December 31, 2021, wastewater service to approximately 9,016 customers in Hardin County, Kentucky, primarily in the city of Radcliff.<sup>3</sup>

7. Hardin District owns and operates the water treatment and distribution system that serves the Fort Knox Military Installation ("Fort Knox"),<sup>4</sup> and the wastewater and storm water drainage systems<sup>5</sup> that serve that installation.

# B. Use of Alternative Rate Filing Procedures to Adjust the Rates of the Radcliff Wastewater System

8. 807 KAR 5:076 establishes a simplified and less expensive procedure for smaller utilities to apply for rate adjustment. Unlike the procedure set forth in the Commission's Rules of Procedure,<sup>6</sup> this procedure does not require an application containing an extensive amount of financial information, a cost-of-service study, or written testimony. It allows for greater flexibility for the Commission and the applicant utility in addressing a request for rate adjustment.

9. 807 KAR 5:076, Section 2 permits a utility to use the alternative rate adjustment procedure if the utility (1) had gross annual revenue in the immediate past calendar year of \$5,000,000 or less; (2) maintained financial records fully separated from a commonly-owned

enterprise; and (3) filed with the Commission fully completed annual reports for the immediate past year and for the two prior years. 807 KAR 5:076, Section 1(4) provides that, if the applicant utility operates "two (2) or more divisions that provide different types of utility service," the applicant's eligibility to use the alternative procedures will be determined based upon "the total amount of revenue derived from the division for which a rate adjustment is sought."

10. Hardin District operates two wastewater systems: the Fort Knox Military Installation Wastewater System ("FKMI Wastewater System") and the Radcliff Wastewater System (collectively "the Systems"). It intends to apply for an adjustment of the rates of its Radcliff Wastewater System this year and wishes to use the alternative rate adjustment procedure set forth in 807 KAR 5:076.

11. For the year ending December 31, 2021, the Radcliff Wastewater System had total revenues of \$4,044,918. Its total revenues for the year ending December 31, 2022, are not expected to exceed \$5,000,000.

12. For the year ending December 31, 2021, Hardin District's FKMI Wastewater System had total revenues of \$2,907,819.

13. If the Radcliff Wastewater System is considered a separate operating division, Hardin District may use the alternative rate adjustment procedure to apply for an adjustment of that System's rates. However, the alternative rate adjustment procedure is not available if the Systems are deemed a single division and their combined total revenues, which exceed \$5,000,000, are considered.

14. The Radcliff Wastewater System's rates were last adjusted in 2014 in Case No. 2013-00050.<sup>7</sup> Prior to submitting its application in that proceeding, Hardin District informally

inquired of Commission Staff as to the use of alternative rate adjustment procedure and was advised that Hardin District was ineligible to use that procedure as the Systems would be considered as one division and their combined revenues exceeded \$5,000,000.

15. In light of that history, Hardin District requests a declaratory order that the Systems are separate and distinct divisions, that each system's eligibility to use the alternative rate adjustment procedures set forth in 807 KAR 5:076 is based on the total annual revenues produced solely by that system, and that either system may use the alternative rate adjustment procedures set forth in 807 KAR 5:076, so long as its total annual revenue does not exceed \$5,000,000.

# C. The Systems Are Separate and Distinct Operating Divisions of Hardin District

16. The Commission has previously recognized the Systems as separate and distinct operations. *See Application of Hardin County Water District No. 1 for a Deviation from 807 KAR 5:071, Section 7(4)*, Case No. 2018-00166 (Ky. PSC Mar. 11, 2019) at 1 ("Hardin District currently operates two independent treatment plants and collection systems, the Fort Knox Military System and the Radcliff System."); *Application of Hardin County Water District No. 1 to Adjust Its Rates for Sewer Service*, Case No. 2013-00050 (Ky. PSC Apr. 29, 2014) at 1, fn. 2 (recognizing the Systems as "separate operations").

17. The Systems serve significantly different customer populations and geographical areas and operate under different procedures.

a. The FKMI Wastewater System consists of a six million gallon per day ("MGD") extended aeration treatment plant, thirty-five lift stations, approximately 416,000 feet of gravity sewer piping, and 51,000 feet of force main piping. Its service area is generally confined to the boundaries of the Fort Knox Military Installation.

b. Hardin District acquired the FKMI Wastewater System on September 30, 2004, under an agreement with the U.S. Government.<sup>8</sup> That agreement requires Hardin District to provide wastewater service to the military installation for a term of fifty (50) years and limits the use of these facilities to serving Fort Knox and the City of Muldraugh.<sup>9</sup> While Hardin District holds legal title to the wastewater facilities, the U.S. Government has granted Hardin District an easement for the construction, operation, maintenance, repair or replacement of the wastewater facilities on Fort Knox for only fifty years.<sup>10</sup> If the Government elects not to renew the easement, then Hardin District must vacate its wastewater facilities within the military installation.<sup>11</sup>

c. Hardin District must submit to the U.S. Government for its review and approval a proposed annual budget for the FKMI Wastewater System upon which the next fiscal year's rate will be based. Hardin District must also submit an Annual Capital Upgrades and Renewals and Replacement Plan that contains a proposed list of improvements for each of the next five years.<sup>12</sup> The U.S. Government selects which of the proposed improvements will be included as a component in the overall rate assessed by Hardin District for sewer service to the military

installation.<sup>13</sup> Hardin District must make its records related to the provision of sewer service to the military installation available for U.S. Government review.<sup>14</sup>

d. The Radcliff Wastewater System consists of a four MGD extended aeration treatment plant, forty-eight lift stations, approximately 683,000 feet of gravity sewer piping and 106,000 feet of force main piping. It provides wastewater services to the residents of the City of Radcliff, Kentucky ("the City") and the unincorporated areas of Hardin County, Kentucky that are located within Hardin District's territory.

e. Hardin District acquired the Radcliff Wastewater System on January 31, 2008, under an agreement with the City. The City transferred legal title to the wastewater system in exchange for Hardin District's assumption of the City's existing debt obligations related to that System and three tracts of real estate.<sup>15</sup> The agreement places no restrictions on Hardin District's ownership of the wastewater system<sup>16</sup> and confers no rights to the City or other entity as to the Radcliff Wastewater System's operation or management. Hardin District is not required to obtain the approval or agreement of any outside agency for the wastewater system's annual budgets, capital expenditures or rates for service (prior to the submission of those rates to the Commission).

f. A map depicting the location and service areas of the Systems is attached as **Exhibit 2** to this Application.

18. While Hardin District has previously combined the statistical data from the FKMI Wastewater System and the Radcliff Wastewater System into a single financial and statistical report comply with 807 KAR 5;006, Section 4(2), Hardin District operates each wastewater system as a separate division and maintains separate accounts and funds for each wastewater system.<sup>17</sup> The costs to operate each system are separately recorded to the appropriate fund. Its annual audit reports contain separate reports on each of the Systems.<sup>18</sup> Each system has specific employees and management personnel assigned to serve only that system. Hardin District has established accounting procedures and practices to properly allocate expenses to a wastewater system if that system shares common expenses with other divisions or has work performed by employees not assigned to that wastewater system.<sup>19</sup>

19. Hardin District maintains separate tariffs for the FKMI Wastewater System and for the Radcliff Wastewater System.

20. Hardin District uses distinctly different methods to revise and adjust its rates for each System's services. Adjustments to the rates for sewer service provided to Fort Knox are determined by negotiations with the U.S. Government and are submitted to the Commission for approval pursuant to tariff filing to revise the terms of Hardin District's contract with the U.S. Government.<sup>20</sup> Adjustments to the rates for the Radcliff Wastewater System's rates for sewer service are made by submitting an application for general rate adjustment.<sup>21</sup>

21. In summary, each wastewater system operates as a distinct division with different objectives and missions, subject to different operating and management rules, and financially independent of the other.

#### D. Deviation from 807 KAR 5:076, Section 2(1)

22. Should the Commission find that the Systems are not separate divisions, the Commission should authorize a deviation from 807 KAR 5:076, Section 2(1) to permit Hardin District to apply for an adjustment of the Radcliff Wastewater System rates using the alternative rate adjustment procedures set forth in 807 KAR 5:076.

23. 807 KAR 5:076, Section 17 authorizes the Commission to permit deviations from807 KAR 5:076 "[u]pon a showing of good cause."

24. Good cause exists to grant a deviation from 807 KAR 5:076, Section 2(1) for the following reasons:

a. Without the requested deviation, Hardin District will be required to use the more expensive and time-consuming procedures set forth in 807 KAR 5:001, Section 16.

b. The circumstances under which Hardin District operates the Systems are unique. No other Commission-regulated sewer utility operates two large wastewater systems of the Systems' size and complexity as wholly independent divisions.

c. The Radcliff Wastewater System's total revenues for the year ending December 31, 2021, and its expected total revenues for the year ending December 31, 2022, will not exceed \$5,000,000. If its operations only are considered, the Radcliff Wastewater System meets the revenue eligibility requirements of 807 KAR 5:076, Section 2(1).

d. Any application for an adjustment of the rates of the Radcliff Wastewater System will not involve the rates of the FKMI Wastewater System.

e. Use of the procedures set forth in 807 KAR 5:001, Section 16 will significantly increase rate case expense. Hardin District estimates that it will incur **additional costs of between \$50,000 and \$75,000**, including consultant and attorney fees, to comply with the requirements of that regulation. Although these rate case expenses are recoverable through rates, the ratepayers of the Radcliff Wastewater System will ultimately bear the higher costs of using the more complicated and expensive procedure.

f. Allowing the use of alternative rate adjustment procedure will not impede the Commission's ability to perform its statutory duties but will allow greater flexibility on the part of the Commission and Hardin District to address the issues presented by Hardin District's application.

### **E. Requested Relief**

WHEREFORE, Hardin District requests that the Commission:

- 1. Place this Application at the head of the Public Service Commission's docket;
- 2. Enter an Order

a. Declaring that the Radcliff Wastewater System is a separate division of Hardin District that provides a service that differs from that provided by Hardin District's other divisions and that, so long as the Radcliff Wastewater System's gross annual revenue does not exceed \$5,000,000, Hardin District may apply for an adjustment of the Radcliff Wastewater System's rates for service using the procedures set forth in 807 KAR 5:076; or alternatively,

b. Find that good cause exists to permit Hardin District to deviate from 807 KAR 5:076, Section 2, and permit Hardin District to apply for an adjustment of the Radcliff Wastewater System's rates for service using the procedures set forth in 807 KAR 5:076 so long as the Radcliff Wastewater Division's gross annual revenue does not exceed \$5,000,000; 3. Enter an Order granting the requested relief without holding an evidentiary hearing in this matter and no later **than February 15, 2023,** to afford Hardin District adequate time to complete the preparation of an application for rate adjustment for its Radcliff Wastewater System by May 1, 2023; and,

4. Grant any and all such other relief to which Hardin District may be entitled.

It appearing to the <sup>C</sup>ourt that "erman <sup>C</sup>. <sup>D</sup>avis and more than 75 other resident freeholders of the district hereinafter described did on July 15, 1952, file their petition herein and that notice of the filing of said petition was published in three issues of the "lizabethtown News and three issues of the Hardin County Enterprise, both newspapers of general circulation in this county, and it further appearing that no objection or exception has been filed herein, and oral proof having been heard by the court, and the <sup>C</sup>ourt being advised, it is now ordered and adjudged by this <sup>C</sup>ourt as follows:

1. The establishment of the following described water district is reasonably necessary for the public health, convenience, fire protection and comfort of the residents, and a suitable name and number for such district is "Hardin County Water District No. 1". Said district is more completely described by name and number and boundary as follows:

"Hardin County "ater District No. 1"


