Response: Employees of the Letcher County Water and Sewer District participate in the Letcher County Fiscal Court's pension and health insurance plans. The fiscal court provides invoices to Letcher County Water and Sewer District identifying their financial obligation of the monthly health insurance and pension expenses. Upon receiving the invoices Letcher County Water and Sewer District remits a check to the Letcher County Fiscal Court for the amount indicated on the invoice.

9. Identify the party that is responsible for complying with the requirements of GASB 68.

Response: Letcher County Fiscal Court is responsible for complying with GASB 68 requirements.

10. Identify the actual CERS employer contribution paid and reported by Letcher District in calendar year 2021.
