Mr. Depp,

Good evening.

It is normal practice for the applicant to place the president or chief executive officer first in the order of presenting witnesses. Scott County states that placing Misters D'Ascendis and Lyons on the stand in the two and three spots of the applicant's case-in-chief (in whatever order you select) provides the highest likelihood that they will be finished on the first two days of the hearing. This specific approach to the order of presentation of witnesses needs to be part of any recommendation/request presented to the Commission.

Another point required for any recommendation/request presented to the Commission is the issue of referred questions. Because it is possible that subsequent Bluegrass Water witnesses may refer questions to Misters Dylan D'Ascendis and/or Tim Lyons, Scott County cannot agree to waive the right to pursue cross-examination upon a referred question.

To be clear: Scott County will work to reasonably accommodate all of Bluegrass Water's witnesses. In passing, while Scott County does not waive the right to ask Mr. D'Ascendis cross-examination questions, Scott County may not have many questions for him. We reasonably anticipate having several questions for Mr. Lyons.
