


5/29/19 Upstream of outfall 001

















5/29/19 Downstream of Outfall 001













An NOV was issued by the Compliance and Operations Branch on 4/23/19 for the following effluent limitation violations. Failing to comply with 401 KAR 5:065, which cites 40 CFR 122.41(a), by failing to comply with the terms and conditions of KPDES Permit No. KY0044164, Outfall 001-2, for Total Ammonia Nitrogen (TAN) during the 2nd Qtr (Apr - Jun) 2016; and 3rd Qtr (Jul - Sept) 2017. The permitted limits for TAN Loading during the months of May through October are a monthly average of 0.83 lbs/day and a maximum weekly average of 1.25 lbs/day. The reported results were a monthly average of 1.726 lbs/day and a maximum weekly average of 1.726 lbs/day for the 2nd Qtr (Apr - Jun) 2016.

The permitted limits for TAN Concentration during the months of May through October are a monthly average of 4 mg/l and a maximum weekly average of 6 mg/l. The reported results were a monthly average of 23 mg/l and a maximum weekly average of 23 mg/l for the 2nd Qtr (Apr - Jun) 2016; and a monthly average of 7.7 mg/l and a maximum weekly average of 7.7 mg/l for the 3rd Qtr (Jul - Sept) 2017.

Paducah Regional Office conducted an investigation on 5/29/19 in response to incident number 2455342. The complainant reported sewage in a stream near the Golden Acres Subdivision waste water treatment plant.

The treatment plant was not in operation at the time of this investigation. The pump motor was not in place and the entire plant was septic. Water in the receiving stream below outfall 001 was black and had a strong sewage smell. The discharging water was also black.

I returned on 6/10/19 to check the status of the plant. No improvements had been made. The pump motor was still out of place. Based on pictures taken during my initial investigation on 5/29/19, it does not appear that any effort has been made to improve the facility. The plant was still septic. A Notice of Violation was issued for the observed violations.

Solids and debris were noted throughout the entire system.

The bar screen was missing and the aeration basin had an island of solids and debris floating on the surface. The waters were grey and septic. The aeration blowers were not working at the time of the inspection. A new blower motor was in the process of being installed. The clarifier effluent channel was held together with wood and clamps. There were solids in the clarifier. There were solids in the chlorine contact basin.

Poor housekeeping was noted at the time of the inspection. There were empty containers strewn throughout the site and a garbage can was overflowing with debris.

The permittee has failed to report spills, bypasses, and non-compliance as required by 401 KAR 5:065 Section 2(1). Visual observations at the time of the inspection noted that solids have entered the receiving stream without a corresponding notification to the Division of Water. General Comments: On November 12, 2019 a compliance evaluation inspection was conducted in accordance with KPDES Permit KY0080845 at Great Oaks WWTP in Paducah, KY. This inspection was scheduled in advance with certified operator Todd Teas. Operator Zach Roach and Todd Teas were both present during the inspection. Terry Merritt, of Bluegrass Water, was contacted for access for records to review after the inspection.

The Groundwater Protection Plan (GPP), lab analysis and chain of custody documents, and DMRs were not available for review for the inspection. DMRs were reviewed in the office. Dissolved Oxygen and Nitrogen limits were both exceeded during August, 209. Mr. Teas and Mr. Merritt said that Microbac had not been sending the results of the samples being taken. Per the KPDES permit, all documentation required by the permit is at the responsibility of the permit holder to maintain and have available for review during inspections. Mr. Merritt said that he had emailed Microbac to have the plant operators added to the email list of lab analysis.

The plant and outfall were observed during the inspection. The plant appeared to be functioning properly and the outfall was clear and free of any solids.
