3. State whether Judy Water participates in the County Employee Retirement System.

Supplemental Response: Judy Water Association does not participate nor is eligible to participate in CERS. Judy Water currently pays 16% into a retirement plan for employees. Judy Water's employee compensation is reviewed and approved by the Board of Commissioners at the annual Board meeting. Judy Water strives to retain qualified, knowledgeable personnel and officers through its compensation package. Retirement benefits are a portion of an employee's compensation. Judy Water's retirement benefits differ from CERS and have been established with the consideration of the overall compensation package for the individuals employed by Judy Water.
