The first week of school (9/6-9/9), kindergarten students will only attend half a day.

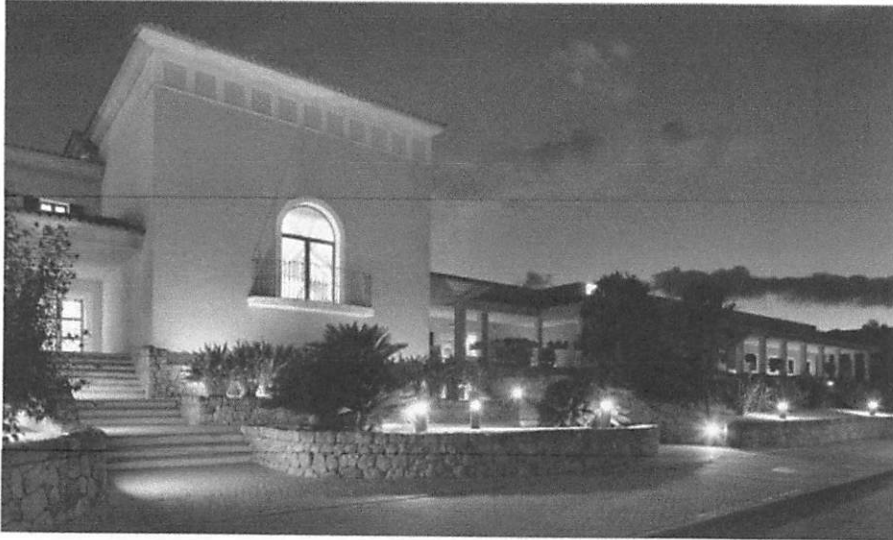
