MOTION FOR EXTENSION OF TIME

Come now the sixteen East Kentucky Power Cooperative, Inc. Cooperatives (“EKPC”) (“Cooperatives”), by and through counsel, and respectfully requests the Kentucky Public Service Commission (“Commission”) to grant an extension of time to file their revised tariffs in the above-styled case, until twenty days after a decision on the Cooperatives’ Motion for Rehearing and/or Clarification is entered. In support of this motion, the Cooperatives respectfully state as follows:

On May 6, 2024, (“May 6th Order”) the Commission entered an Order in this proceeding approving the charges and credits applied by each individual Cooperative through the Fuel Adjustment Clause (“FAC”) for the period from November 1, 2020 through October 31, 2022. The Commission’s May 6th Order also ordered each Cooperative to increase its base energy rates for service rendered on or after June 1, 2024, adjusted for line loss to reflect the increase of \$0.01125 per kWh by EKPC in Case No. 2023-0009. The Commission’s Order went on to list the amounts that each Cooperative should increase its base energy rates.

After reviewing the Commission’s Order, it was determined that the amounts calculated by the Cooperatives in the responses to data requests in this proceeding, were not used as the amounts ordered by the Commission to place into effect for service rendered on or after June 1,

2024. Furthermore, the Cooperatives have been unable to determine why the calculations provided by the Cooperatives were not used or how the Commission's Order calculated the rates approved.


Contemporaneously with this Motion, the Cooperatives are filing a Motion for Rehearing and/or Clarification on the Commission's May 6th Order. If the Cooperatives are successful in their Motion for Rehearing and/or Clarification, the rates approved by the Commission in the May 6th Order will change.

WHEREFORE, on the basis of the foregoing, the Cooperatives respectfully request that the Commission grant the following:

1. an extension for each of the Cooperatives, until twenty days after the Commission enters a decision on the Cooperatives' Motion for Rehearing and/or Clarification, to file the updated FAC tariffs in this proceeding; and,
2. all other relief to which the Cooperatives may be entitled.


