**Request 2:** Refer to the monthly Form A rate sheet filings for the period under review and the Cooperatives' responses to Commission Staff's First Request for information (Staff's First Request), Item 1 and Item 4.

**Request 2a:** For each month of the two-year period under review, reconcile the discrepancies, if any, between the two filings.

**Response 2a:**

- The dates were incorrectly labeled on all monthly Form A rate sheet filings for the 24 months. Jackson Energy is filing an amended form for each month to correct the dates – see attached.
- May 2021 – Line 1 - Total Purchases – this was incorrect. Jackson Energy is filing an amended return to correct this. This also carried over incorrectly for the next 11 months. This was also corrected.
- May 2022, June 2022, July 2022 – Line 1 – Total Purchases – this line was incorrect on each of these filings. Jackson Energy is filing an amended form to correct Total Purchases.
- In the September 2023 filing, we used the October 2021 line loss rate instead of the October 2022 line loss rate. This has been corrected but this did not change our calculation.

**Request 2b:** If there are discrepancies, provide the impact of the discrepancy for that month. If the discrepancy results in an under-recovery or an over-recovery for the review period, provide the proposed plan the utility has to address the issue.

**Response 2b:**

- The discrepancies are listed above – these discrepancies did not have an impact on the review period or on member billing.
