If the Public Service Commission approves the proposed residential rates, then the Phase 1 monthly sewer bill for a residential customer using an average of 2,500 gallons per month will increase from \$17.90 to \$33.36. This is an increase of \$15.46 or 86.4%. If the proposed rates are approved, then the Phase 2 monthly sewer bill for a residential customer using an average of 2,500 gallons per month will increase from \$33.36 to \$43.80. This is an increase of \$10.44 or 31.3%.

If the Public Service Commission approves the proposed commercial rates, then the Phase 1 monthly sewer bill for a commercial customer using an average of 3,500 gallons per month will increase from \$34.20 to \$63.74. This is an increase of \$29.54 or 86.4%. If the proposed rates are approved, then the Phase 2 monthly sewer bill for a commercial customer using an average of 3,500 gallons per month will increase from \$63.74 to \$83.67. This is an increase of \$19.93 or 31.3%.

It is proposed that Phase 2 rates will be implemented one year after the effective date of Phase 1 rates. The rates contained in this notice are the rates proposed by Edmonson County Water District. However, the Public Service Commission may order rates to be charged that differ from these proposed rates. Such action may result in rates for consumers other than the rates shown in this notice.

Edmonson County Water District has available for inspection at its office the application which it submitted to the Public Service Commission. A person may examine this application at Edmonson County Water District's office located at 1128 US Hwy 259N, Brownsville, KY 42210. You may contact the office at 270-597-2165.

A person may submit a timely written request for intervention to the Public Service Commission, PO Box 615, Frankfort, KY, 40602, establishing the grounds for the request including the status and interest of the party. If the Public Service Commission does not receive a written request for intervention within thirty (30) days of the initial publication of this notice, the Public Service Commission may take final action on the application.
