1 **Item 1)**      *Refer to Direct Testimony of Talina Smith at Exhibits 2 and 3.*  
2 *Regarding the \$9.2 million to be credited to rural customers, provide a*  
3 *calculation for the bill impact for the flow through of that amount for a*  
4 *residential customer of average usage on a monthly and annual basis.*

6 **Response)** The bill impact in 2023, for all rural customers, including residential,  
7 will depend on the actual usage each month. Assuming the 2023 rural sales volume  
8 is the same as 2022 (2,268,701 MWhs), the average residential customer bill credit  
9 will be approximately \$ 4.00 per MWh (\$9.2 million / 2.3 million MWhs), or  
10 approximately \$55.30 for the year 2023, or approximately \$4.61 monthly (assuming  
11 2021 average residential usage of 1,152 kWh per month).
