Property Acquisition Update

Kentucky Power files with the Commission its September 2024 property acquisition update. The filing is being made in accordance with paragraph 58 of the Company’s application. This update details the status of Kentucky Power’s property acquisition efforts as of September 3, 2024. No opposition has been expressed.

The Company has begun surveying the parcels affected by the Belfry Area Transmission Line Project, and as a result, has obtained more accurate parcel information than that provided by the PVA. The Company is still confirming some parcel information. **EXHIBIT 1** provides further information regarding the status of the 36 parcels. The Company has acquired seven of the 36 parcels affected by the transmission line or its right-of-way.
