Notice Of Intent

Pursuant to KRS 278.020, 807 KAR 5:120, Section 1, and all other applicable statutory provisions and regulations, Kentucky Power Company gives notice of its intent to file on or after April 3, 2023, an application seeking a certificate of public convenience and necessity to retire and rebuild approximately 6.5 miles of an existing 46 kV transmission line located in the Commonwealth in Pike County, Kentucky ("Project"). The Project will involve:

- (a) The retirement of the existing 8.2 mile 46 kV transmission line between the existing Stone Substation in Pike County, Kentucky and the Sprigg Substation in Mingo County, West Virginia. Kentucky Power will only perform the work related to the 6.5 mile portion of the transmission line located in the Commonwealth;
 - (b) The retirement of the existing Belfry 46 kV Substation in Pike County, Kentucky;
 - (c) The retirement of the 0.75 mile Turkey Creek 69 kV Tap transmission line;
 - (d) The construction of the Orinoco 69 kV Substation in Pike County, Kentucky; and
- (e) The construction of approximately 6.5 miles of 69 kV transmission line in Pike County, Kentucky between the existing New Camp 69 kV Substation and the existing Stone 69 kV Substation via the new Orinoco 69 kV Substation;

(f) The performance of related work, including certain substation equipment

retirements, at the Stone 69 kV Substation and the New Camp 69 kV Substation;

The performance of reconfiguration work at the New Camp 69 kV Tap; and (g)

(h) The performance of related distribution line work to connect the Orinoco 69 kV

Substation and the existing distribution line system.

The construction in the Commonwealth of Kentucky is limited to Pike County, Kentucky.

A map illustrating the major project components is attached.

The proposed 69 kV transmission line will be built using both existing right-of-way and

right-of-way to be acquired. The right-of-way will generally be maintained at a 100 foot width,

except where a wider right-of-way of up to 400 feet is required in areas of unusually steep terrain

or where doing so is required by the safe and efficient operation of the proposed transmission

line.
