Cellco Partnership, d/b/a Verizon Wireless (“Applicant”), by counsel, pursuant to (i) KRS §§278.020, 278.040, 278.650, 278.665, and other statutory authority, and the rules and regulations applicable thereto, and (ii) the Telecommunications Act of 1996, respectfully submits this Second Amended Application requesting issuance of a Certificate of Public Convenience and Necessity (“CPCN”) from the Kentucky Public Service Commission (“PSC”) to construct, maintain, and operate a Wireless Communications Facility (“WCF”) to serve the customers of the Applicant with wireless communications services.

In support of this Application, Applicant respectfully provides and states the following additional information in response to the July 7, 2023 request for additional information.

Provide all documentation, including the original documents obtained from the Knox County Property Valuation Administrator, that Verizon Wireless relied upon to create the list of adjacent property owners entitled to notification:

Attached as **Exhibit 1** please find the notice list accompanied by screenshots from of each property record including parcel number and mailing address. This was conducted by our offices on July 14, 2023 utilizing the Knox County PVA. All ownerships and addresses were verified as unchanged.

Exhibit 2 contains copies of the notices and map sent, copies of all envelopes, returned green cards, returned envelopes and USPS Tracking information. Twenty-two (22) notices were sent to surrounding property owners on March 9, 2023; to date fourteen (14) notice green cards have been returned, 7 of the mailed notice envelopes have been returned and according to the United States Postal Service Tracking Number 702204100000217991195 evidence updated July 17, one (1) mailed notice was delivered, but no green card has been returned. There are no unaccountable notices. Applicant would suggest that the Tracking information from the United States Postal Service is sufficient to meet the requirements of KRS 278.665(2) and 807 KAR 5:063, Section 1(1)(a)(l)(1).


