# Application of MCImetro Access Transmission Services LLC d/b/a Verizon Access Transmission Services

MCImetro Access Transmission Services LLC d/b/a Verizon Access Transmission Services (a/k/a OCN 7229; hereinafter referred to as "Verizon Access") files this application pursuant to 807 KAR 5:001 § 14 and 47 C.F.R. § 52.15(g)(3)(iv), and respectfully requests that the Kentucky Public Service Commission ("Commission") issue an order that reviews and reverses the decision of the North American Numbering Plan Pooling Administrator ("PA") to withhold certain numbering resources from Verizon Access. The requested numbering resources are necessary to meet the telecommunications needs of a Verizon Access customer, Encompass Health, in the Lexington Kentucky rate center. Encompass Health is now converting to Cisco PBX at its existing 232-bed hospital in Lexington, Kentucky, and needs additional direct inward dialing ("DID") lines. In support of its Application, Verizon Access states as follows:

- 2. Verizon Access is a limited liability company (LLC) organized in Delaware on May 28, 1998, with its principal office at One Verizon Way, Basking Ridge, NJ 07920. Applicant attests that it is currently in good standing in the state of Delaware, and states that it is authorized to transact business in Kentucky, having qualified to do so on December 27, 2002, and maintained that authority ever since.
- 3. Verizon Access is a telecommunications utility regulated by the Commission. It provides, among other telecommunications services, local exchange and exchange access services in the Commonwealth of Kentucky.<sup>1</sup>
- 4. As mentioned above, this Application is prompted by Encompass Health's need for DID in the existing hospital phone system. This requires a contiguous range of 300 DID numbers for NPA 859. The first digit of the last four digits cannot start with a 9 or a zero. Encompass Health has placed an order with Verizon Access for the contiguous DID numbers. See Exhibit 1. If Encompass Health cannot obtain the requested 300 contiguous DID numbers, it will impact its ability to implement its desired dial plan for efficient internal communication at the hospital.
- 5. Because Verizon Access lacked a block of contiguous DID numbers with which to meet Encompass Health's needs, on January 13, 2023, it submitted a thousands-block request to the PA for a contiguous block in the Lexington, Kentucky rate center, along with the necessary Worksheet. *See* Exhibit 2.<sup>2</sup>

- 6. On January 13, 2023, the PA denied the request on the grounds that Verizon Access had not met the utilization and/or months-to-exhaust criteria established by the Federal Communications Commission ("FCC"). See Exhibit 3.
- 7. Verizon Access asks the Commission to overturn the PA's decision to withhold numbering resources, as Verizon Access has now exhausted all other available remedies designed to conserve numbering resources. The Commission has previously overturned decisions of the PA where the facts similarly show a need therefor,<sup>3</sup> including a similar matter on behalf of Verizon Access for its customer Encompass Health.<sup>4</sup>
- 8. A state commission may overturn the PA's decision based on the commission's determination that the carrier has demonstrated a verifiable need for the requested numbering resources and has exhausted all other available remedies. See 47 C.F.R. § 52.15(g)(4). Similarly, the FCC has held that "a carrier should be able to get additional numbering resources when there is a verifiable need due to the carrier's inability to satisfy a specific customer request." See Third Report and Order and Second Order on Reconsideration, In the Matter of Numbering Resource Optimization; Implementation of the Local Competition Provisions of the Telecommunications Act of 1996; Telephone Number Portability, 17 FCC Rcd 252 (rel. Dec. 28, 2001) at ¶ 64 ("12/28/01 FCC Order"). State commissions are permitted to grant such requests provided they are for customers seeking contiguous blocks of numbers, rather than "vanity numbers." Id.
- 9. In this case, Encompass Health requires a contiguous range of DID numbers for NPA 859. Granting this application will benefit the public interest because it will ensure the

availability of adequate numbering resources for Encompass Health to better enable it to serve its patients.

WHEREFORE, Verizon Access respectfully requests that the Commission overturn the PA's previous determination in this matter as expeditiously as possible, and instruct the PA to release the numbering resources necessary to meet the needs of Encompass Health. Verizon Access further requests that if the specific resources are not available when the Commission issues its order, that it direct the PA to provide such resources as are available to meet Encompass Health's numbering needs.


