SECOND MOTION TO AMEND ORDER

Green River Valley Water District ("Green River Valley") moves the Public Service Commission ("Commission") to amend its Order of October 30, 2023 to correct certain typographical errors.

In support of its Motion, Green River Valley states:

- 1. On October 30, 2023, the Commission issued an Order approving new rates and fees for water service provided by Green River Valley. These new rates and charges are listed in Appendix B to this Order. A copy of Appendix B is attached to this Motion as **Exhibit A**.
- 2. In its Order of October 30, 2023, the Commission noted that Green River Valley's cost-of-service study was used to calculate the retail rates and wholesale rate.¹ It further stated:

Green River Valley District's proposed rates are based on the rate design currently applied to Green River Valley District's current customer classifications. The proposed

rates have been increased by the COSS previously discussed.2

With the exception of the 5/8-inch x 3/4-inch meter classification, the 3.

volumes for each meter service size listed in Appendix B differ from those

currently in Green River Valley's tariff and those proposed in Green River

Valley's cost-of-service study. Each meter service size in Green River Valley's

current tariff and in Green River Valley's cost-of-service study has either three or

four rate steps, with the last step being for usage over 30,000 gallons. The last step

of each meter service size in Appendix B, however, with the exception of the 5/8-

inch x 3/4-inch meter class, is for usage over 50,000 gallons. For the 2-inch meter

service, there is no rate provided for usage between 30,001 gallons and 50,000

gallons.³ For the purpose of comparison, Green River Valley's rate schedule as of

October 30, 2023, its proposed rates as set forth in Exhibit 3 of its Application, and

the cost-of-service study's proposed rates are attached to this Motion as **Exhibit B**,

Exhibit C, and **Exhibit D** respectively.

Under the rate steps found in Green River Valley's current tariff and 4.

its proposed rates, a customer is charged a lower rate for all monthly usage that

\$110.42 Minimum Bill 0.00589 Per Gallon 0.00489 Per Gallon exceeds 30,000 gallons. Under the rate steps in Appendix B, all customers, except those served through a 5/8-inch X 3/4-inch meter, will not be charged the lower rate until their usage exceeds 50,000 gallons. As a result of the higher rate being assessed for monthly water usage between 30,001 gallons and 50,000 gallons, the rates currently set forth in Appendix B will produce revenues from water sales that are in excess of the \$6,092,630 that the Commission authorized in its Order of October 30, 2023.

- 5. In its initial review of the October 30, 2023 Order, Green River Valley noticed inconsistencies between the rates authorized for a 5/8-inch x 3/4-inch meter connection and the minimum bill for a 1.5-inch meter and immediately brought those inconsistencies to the Commission's attention. However, it failed to notice the inconsistencies associated with the rate steps until preparing revised tariff sheets to reflect the amended rates resulting from the Commission's Order of November 13, 2023.
- 6. Green River District believes the inconsistencies to be the result of inadvertent typographical errors.

WHEREFORE, Green River Valley requests that the Order of October 30, 2023 be amended to correct the typographical errors in the volumes for the rate steps associated with the each meter class other than the 5/8-inch x 3/4-inch meter class and that such amendment be retroactive to October 30, 2023.


