12	Comes Big Rivers Electric Corporation ("Big Rivers"), by counsel, and		
13	respectfully moves the Kentucky Public Service Commission (" $Commission$ ") to		
14	grant an extension of time to file revised tariff sheets in this matter, until 20 days		
15	after a decision on Big Rivers' Petition for Rehearing is entered. In support of this		
16	motion, Big Rivers states as follows:		
17	1. On December 15, 2023, the Commission issued an Order (the		
18	"December 15 Order") (i) denying the rates Big Rivers proposed in its QF Tariff that		
19	is the subject of this proceeding, and (ii) approving the rates and charges set forth in		
20	the Appendix to that Order.		
21	2. The December 15 Order directed Big Rivers to file, within 20 days of		
22	service of that Order, new tariff sheets setting for the terms, rates, and charges		
23	approved in that Order.		
24	3. On January 5, 2024, Big Rivers filed a Petition for Rehearing of the		
25	December 15 Order.		

1	4. If the	Commission grants rehearing of the December 15 Order, in		
2	whole or in part, the rates and charges approved by the Commission in the			
3	December 15 Order could change.			
4	5. Big Ri	ivers believes that putting the rates approved in the December 15		
5	Order into effect now, and possibly having to put different rates into effect if Big			
6	Rivers' Petition for Rehearing is granted, will cause confusion and undue			
7	administrative burden for Big Rivers' Members and their retail customers who are			
8	or could be served through the QF Tariff.			
9	6. Big Ri	ivers requests that the Commission grant an extension of time for		
10	it to file updated tariff sheets until 20 days after the Commission issues a decision			
11	on Big Rivers' Petition for Rehearing.			
12	WHEREFORE, based on the foregoing, Big Rivers respectfully requests that			
13	the Commission grant it an extension, until 20 days after the Commission enters a			
14	decision on Big Rivers' Petition for Rehearing, to file updated tariff sheets in this			
15	proceeding.
