ESTABLISHING

COMMISSIONER'S COMPENSATION FOR  
EAST LAUREL & WOOD CREEK WATER DISTRICTS

WHEREAS, KRS 74.020(6) places the responsibility and authority for establishing the level of a water district commissioner's salary upon county judges/executives and fiscal courts and;

WHEREAS, the Laurel County Judge/Executive and the Laurel County Fiscal Court has a desire to set the East Laurel & Wood Creek Water Districts salaries for the commissioners in accordance with the state guidelines;

**IT IS HEREBY RESOLVED**, effective March 1, 2016, the Laurel County Judge/Executive and the Laurel County Fiscal Court sets the salaries at \$300.00 per month for each commissioner if they have not completed six (6) instructional hours of water district management training approved by the Public Service Commission. Each commissioner that annually receives six (6) hours of water district management training approved by the Public Service Commission will be paid \$500.00 per month.
