**RESPONSE TO FIRST REQUEST FOR INFORMATION TO APPLICATION FOR  
CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY  
FOR CONSTRUCTION OF A WIRELESS COMMUNICATIONS FACILITY**

Public Service Commission (PSC) Staff’s Request:

1. Refer to KRS 278.665(2) and 807 KAR 5:063, Section 1(1)(a)(1)(1). Provide all documentation, including the original documents obtained from the Graves County Property Valuation Administration (PVA), that the Joint Applicants relied upon to create the list of adjacent property owners entitled to notification.

**Please note, new response information noted in red.**

Cellco Partnership, d/b/a Verizon Wireless and VB BTS II, LLC d/b/a Vertical Bridge (“Co-Applicants”), submitted an application requesting a Certificate of Public Convenience and Necessity to construct a Wireless Communications Facility in the Commonwealth of Kentucky in the County of Logan on June 8, 2023:

There were thirteen (13) notices sent to surrounding property owners on April 21, 2023; to date ten (10) notice green cards have been returned. After additional research, Seventeen

(17) notices were sent to the additional surrounding property owners on June 6, 2023 and three (3) notices were resent to property owners on the original list that have not been returned, also on June 6, 2023.

Updated information:

**A. Exhibit 1** includes a map drawn to an appropriate scale that shows the location of the proposed tower and identifies every owner of real estate within 500 feet of the proposed tower (according to the records maintained by the County Property Valuation Administrator). This map and the associated Notice List are accompanied by a certificate signed and stamped by the registered surveyor that said information is from the PVA records, dated April 20, 2023.

**B.** Please see **Exhibit 2** which includes the notice list accompanied by screenshots from of each property record including parcel number and mailing address. This was conducted by our offices on June 20, 2023 utilizing the Graves County PVA. All ownerships and addresses were verified as unchanged.

2. For each of the adjoining property owners to whom notice was sent by certified mail, return receipt requested, provide a copy of all signed United States Postal Service Form 3811, otherwise known as “signed green cards,” or a copy of the notice that the certified mail was returned to the Joint Applicants as undelivered by the United States Postal Service. This data request is continuing and should be updated in a supplemental filing until all signed green cards and undelivered notices are returned to the Joint Applicants.

**C.** Fourteen (14) notices were sent to surrounding property owners on April 21, 2023 (one was a duplicate); After additional research, seventeen (17) notices were sent to

the additional surrounding property owners on June 6, 2023, and three (3) notices were resent to property owners on the original list that have not been returned, also on June 6, 2023. Therefore, notices sent total 31. To date twenty-six (26) USPS Service Form 3811 (green cards) have been returned, three (3) notice envelopes have been returned, one (1) USPS search shows that the notice to Willett, Williams Merrett was delivered June 10, 2023, and one (1) USPS search indicates that a notice was left for Thomas, Daniel A & Jennifer on June 8, 2023 and a reminder was left to reschedule delivery on June 13, 2023. There are no unaccountable notices. Copies of the notification letter, location map, mailed envelopes, twenty-six (26) returned green cards, three (3) returned envelopes and two (2) USPS search documents are attached as **Exhibit 3**.

**D.** Attached hereto as **Exhibit 4** please find an Affidavit of Certification for all information contained in this application.


