## AMENDMENT No. 3

## CONSULTING OR REPAIR SERVICES AGREEMENT City of West Point

THIS THIRD AMENDMENT TO THE ABOVE NOTED Consulting or Repair Services Agreement is effective January 14, 2016, between Hardin County Water District No. 1 ("District") and the City of West Point ("City"),

WHEREAS, The District and the City do hereby extend and revise the original Agreement dated November 18, 2011, including Amendment No. 1 which was effective November 26, 2012 and Amendment No. 2 which was effective November 19, 2014, and

NOW THEREFORE, the District and the City agree to modify the original Agreement and previous Amendment as follows;

- 1. The monthly service fee as originally included with Attachment A, Item B, shall be increased in accordance with Section III, E of the Agreement, and said amount for Item B shall be changed to;
  - B. BASE MONTHLY SERVICE FEE: = \$488.87 per month
- 2. The table with hourly rates and overhead percentages as originally included with Attachment A, at Section II.B.1., Hourly Rates, are changed and replaced with the following;

- 2. Additional items / personnel not listed in table;
  - a. Personnel Will be charged at current hourly rate, +40.4% benefits / taxes overhead, +4.4% G&A adder
  - b. District Equipment Annual depreciation rate / 2080 hours, +4.4% G&A, + equiv hourly rate operating costs (fuel & maintenance)
  - c. Materials Actual costs, District paid, + any delivery or shipping costs

- 3. Section D, <u>Term</u>, of the original Agreement shall be replaced in its entirety with the following;
  - "<u>Term:</u> This agreement may be terminated by either party by providing no less than fifteen (15) days written notice to the other party. The term of the Agreement shall be for one (1) year periods, beginning on December 1 of each year and ending on November 30<sup>th</sup> of each year. If neither party has elected to terminate the agreement on the renewal date, the term shall automatically renew for another year".
- 4. WHEREAS, the City wants to contract with the DISTRICT for scope of one time services listed in the table below and the City agrees to pay the total costs for the services/materials listed and the DISTRICT agrees to perform the services listed below.
