# MEMORANDUM OF PARTIAL CLOSING

This Memorandum of Partial Closing is executed this the 24<sup>th</sup> Day of October, 2023, by the Hardin County Water District, No. 1, ("**HCWD1**") in connection with the closing of the Assets identified under the Acquisition Agreement for the Water and Wastewater System of the City of West Point dated as of April 25, 2023 (the "Acquisition Agreement"),

# **RECITALS**:

**WHEREAS**, on April 25, 2023, HCWD1 and the City of West Point (the "**City**") (collectively as the "**Parties**") entered into the Acquisition Agreement for the sale and purchase of the City's water and wastewater system; and

WHEREAS, on May 5, 2023 the Parties filed a Joint Application with the Kentucky Public Service Commission (the "Commission") under Case No. 2023-00143 requesting a Certificate of Public Convenience and Necessity ("CPCN") for HCWD1 to acquire the City's water and wastewater system. On September 20, 2023, the Commission entered an Order approving a CPCN for HCWD1 to proceed with closing and amend its tariff accordingly, notifying the Commission within 10 days of Closing; and

WHEREAS, on October 23, 2023, the Parties executed a Bill of Sale to acquire the water and wastewater assets (the "Assets") of the City and execute of a payoff of the City's USDA/Rural Development loan and KIA loan. *See attached Bill of Sale*. Concurrently, the Parties executed a Partial Extension of Closing for the real estate of the water and wastewater system pending survey completion and execution of deeds and easements. *See attached Partial Extension of Closing*.

**NOW THEREFORE**, HCWD1 states to the Commission as follows:

1. All terms, conditions and covenants of the Parties contained in the Acquisition Agreement have been fully satisfied, except for the transfer of recorded and unrecorded real estate. The recording and transfer of real estate shall occur within 21 days following completion of required surveys.

2. HCWD1's tariff remains unaffected by the acquisition of West Point's water and wastewater system, however, the cover page of HCWD1's tariff will be updated to reflect furnishing of water service in Hardin and Meade Counties.

3. A "Memorandum of Final Closing" shall be tendered to the Commission within 10 days of closing on the real estate, unless otherwise required by the Commission.
