



Notice is hereby given that the Kentucky Public Service Commission (the “Commission”) will conduct a hearing at 9:00 a.m. Eastern Daylight Time on Thursday, October 26, 2023, in the Richard Raff Hearing Room 1 at the Commission’s offices at 211 Sower Boulevard, Frankfort, Kentucky, 40602, for the purposes of cross-examination of witnesses of Taylor County Rural Electric Cooperative Corporation (“Taylor County RECC”) in PSC Case No. 2023-00147, regarding Taylor County RECC’s Application for a rate increase.
