KSP Post 15 welcomes new telecommunicators

The Kentucky State Police announced 30 telecommunicators, representing 13 posts across the state, have graduated from the KSP Telecommunications Academy. It was the agency's largest graduating class in its history.

A release from the state police said graduates coming to Post 15 out of the 22nd KSP Telecommunications Academy are:

• MaKenzie Hughes, an Adair County resident, who is a graduate of Taylor County High School. She is the daughter of Ricardo and Miriam Hughes.

• Brady Bell of Russell Coun-

ty, a graduate of Russell County requests for assistance. High School, and the son of Neil and Lisa Bell.

The agency is continuing to recruit for individuals to provide critical assistance and assurance to their neighbors and loved ones. KSP telecommunicators have the ability to receive an annual \$3,100 training stipend.

KSP telecommunicators handle dispatch duties for Kentucky state troopers, commercial vehicle enforcement officers, conservation officers and other emergency service agencies as needed. In 2022, telecommunicators answered over 622,000 calls resulting in more than 396,000

The graduates of Class 22 received 160 hours of instruction over four weeks. Major training areas include legal liability, limits of telecommunicator authority, telecommunicator's role in public safety, interpersonal communications, customer service, combating stress and PTSD, ethics and confidentiality, responder safety, basic fire dispatch, state emergency operation plans, criminal justice information systems, first aid training, emergency medical dispatch and special needs callers.

During the academy, graduates were required to success-

fully process scripted calls for service and demonstrate proficiency in obtaining pertinent information, dispatching first responders, providing emergency medical dispatch if needed, and correctly documenting information from the call for assistance. The training concluded with a computer simulation system that simulates their work environment in the radio room.

ardy heirloom mums are very different from the potted mums we see for sale this time of the year. One of the largest differences is that heirloom mums can last for many years.

My grandmother's mums are at least 40 years old. The heirloom mums bloom in the autumn (November) as a perennial. They grow in full sun with welldrained soil. Irrigation will need to be increased during dry periods.

Heirloom mums do well with water soluble fertilizer applied throughout the summer. Mulch around the plant will help suppress weeds and retain moisture.

Plant these mums in the early spring. Do not plant them in the autumn. The roots will not develop enough in

You do not have to cut them back during the growing season unless you want to reduce the height of the plant. These mums can reach 24 to 36 inches in height. I pruned them this year in June and it seems more flower buds formed as a result.

Plant these mums in the back of the perennial bed allowing shorter plants to be planted in the front. The old stems from the previous year will die.

I trim these off three to four inches from the soil level to allow for the new year's growth to emerge. These heirloom mums will spread over time. So, you will easily be able to share with friends.

1. Avoid Distracted Driving. According to NHTSA, driver distraction is the leading factor in most crashes. Avoid distractions, like talking or texting on cell phones, talking to passengers, adjusting audio and climate controls in the vehicle and eating or drinking while driving. Additionally, headphones are not safe to wear while driving, as they can distract a driver from hearing sirens, horns or other important sounds.

2. Wear Seat Belts. Wearing a seat belt is the best protection against injury and death, yet according to NHTSA, teens are less likely to be buckled up than members of any other age group. Properly fastened seat belts contact the strongest parts of the body, such as the chest, hips and shoulders. A seat belt spreads the force of a crash over a wide area of the body, putting less stress on any one part, and allows the body to slow down with the impact, extending the time when the occupant feels the crash forces.

3. Take Extra Caution While Driving with Passengers. Passengers in a teen's car can lead to tragedy. NHTSA research shows that the risk of a fatal crash goes up dramatically in direct relation to the number of passengers in a car. The likelihood of teen drivers engaging in risky behavior triples when traveling with multiple passengers.

4. Obey Speed Limits. Limits are put in place to protect all road users. Driving over the speed limit greatly reduces a driver's ability to steer safely around another vehicle,

AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES OF THE CITY OF LEBANON, KENTUCKY




