**Notice Regarding Development Of Service Reconnection Standards**

As part of the Settlement Agreement submitted by Kentucky Power Company (“Kentucky Power” or “Company”) in this case, Kentucky Power agreed to collaborate with the Joint Intervenors (Mountain Association, Appalachian Citizens Law Center, Kentuckians For The Commonwealth, and Kentucky Solar Energy Society) to develop service reconnection standards that would enable residential customers to be reconnected based on to-be-determined partial payment and repayment plan terms. Kentucky Power committed to make a filing seeking Commission approval of the standards by no later than June 1, 2024, if Commission approval were required. The Commission also directed in its January 19, 2024 Order that if Kentucky Power were to determine that Commission approval were not required, then Kentucky Power should still notify the Commission of the standards through a post-case filing in this proceeding.<sup>1</sup>

Although the Commission denied Kentucky Power’s motion to approve the Settlement Agreement in its January 19, 2024 Order, the Company nonetheless is honoring its settlement commitments with respect to the service reconnection standards. The Company has been collaborating in good faith with the Joint Intervenors to develop enhanced service reconnection standards since the Commission issued its January 19, 2024 Order. However, the Company and

the Joint Intervenors require more time to continue their collaboration to develop enhanced standards.

The Company hereby files this notice, prior to June 1, 2024, indicating as such in conformity with the Commission's January 19, 2024 Order. The Company and Joint Intervenors will continue to work diligently and in good faith to develop enhanced service reconnection standards, and Kentucky Power will make a subsequent filing with the Commission either requesting approval of the standards, if required, or otherwise providing the by the January 19, 2024 Order, within 30 days of any enhanced service reconnection standards being finalized.
