Notice of Filing

Kentucky Power Company (“Kentucky Power” or the “Company”) hereby files Attachment 8 to the Company’s response to KPSC 2-2, which is a large Excel file. The Company made good faith efforts to file this Excel attachment at the same time it filed all other responses to data requests on August 28, 2023. However, due to either the file size or the file type,¹ or a combination of both, the Company was unable to successfully file the attachment through the Commission’s electronic filing system. ¹ The Company understood from the Commission’s October 6, 2022 Order in Case No. 2022-00311 that the Company was permitted to file through the Commission’s electronic filing system, “Zip files for audio and video files, or accepted PDF or Excel spreadsheet file formats greater than 50 MB that cannot be submitted in multiple uploading sessions or macro enabled Excel spreadsheets, including .xlsm or .xlsb.” October 6, 2022 Order at 3. The Company attempted to file the attachment as a zip file in .xlsb format, which was rejected by the electronic filing system. The Company has since spoken with Commission Staff and confirmed that the filing approach described herein is acceptable.
