**Notice of Filing Rates To Be Implemented After Appeal**

Kentucky Power Company (“Kentucky Power” or the “Company”) hereby files with the Public Service Commission of Kentucky (“Commission”) rate calculations to implement the Franklin Circuit Court’s order on appeal in Case No. 25-CI-310 (“Order”), which directs the Commission to “enter an order within 30 days of entry of this Order setting rates, or employing other appropriate ratemaking mechanisms, sufficient to enable Kentucky Power to collect \$15,726,307 in transmission expenses and rate case expenses that it should have collected beginning January 16, 2024, through February 20, 2025.”<sup>1</sup>

Kentucky Power, Commission Staff, and representatives of the intervenors in this case met for an informal conference on September 26, 2025, to discuss the implementation of the Franklin Circuit Court’s Order. The Company proposes that the amounts be collected through a temporary rider over 22 months beginning with the November 2025 billing cycle. The Excel file titled “KPCO\_WP\_for\_Recommendation” provides the rate calculations to effectuate that proposal, and is consistent with the Franklin Circuit Court’s Order.
