**Kentucky Power Company’s Motion to Participate Virtually**

Kentucky Power Company (“Kentucky Power” or the “Company”) respectfully moves the Public Service Commission of Kentucky (“Commission”) **for an order to be issued no later than November 28, 2023** permitting Company Witness Lerah M. Kahn to participate remotely by videoconference at the hearing in this proceeding scheduled to begin November 28, 2023. Ms. Kahn filed direct testimony and responses to data requests in this proceeding.

Ms. Kahn tested positive for COVID-19 on Friday, November 17, 2023, on Friday, November 24, 2023, and again on Sunday, November 26, 2023. Ms. Kahn is well enough to participate in the hearing, but consistent with CDC guidelines for individuals with symptoms that remain the same, should remain in isolation. Ms. Kahn is equipped with the technology necessary to enable remote participation, and if granted leave to appear remotely, will participate in a test of technology with Commission Staff to ensure that her audio and video capabilities, and ability to share documents remotely if needed, are sufficient. Ms. Kahn’s virtual participation would not prejudice the Commission or any party.

WHEREFORE, Kentucky Power Company respectfully requests the Commission to enter an Order no later than November 28, 2023:

1. Permitting Lerah M. Kahn to appear and participate remotely by videoconference at the hearing in this matter scheduled to begin November 28, 2023; and

2. Granting Kentucky Power all further relief to which it may be entitled.
