Kentucky Power Company's Motion to Supplement the Record

Kentucky Power Company ("Kentucky Power" or the "Company") respectfully moves the Public Service Commission of Kentucky ("Commission") to supplement the record of this case with the itemized invoices supporting the costs charged by the consultants and other advisors retained by the Commission in this case pursuant to Kentucky's securitization statute, KRS 278.674(3).

Kentucky Power is required to pay the costs associated with the retention of the Commission's consultants, which will then be included as financing costs in the securitized surcharge and ultimately recovered from Kentucky Power customers.¹ The Commission issued orders on October 9, 2023, October 30, 2023, November 22, 2023, and December 22, 2023 providing the consultant charges incurred and to be paid by Kentucky Power. Each order includes a copy of the required Personal Service Contract Invoice Form that provides, among other administrative information, the total amount charged for the respective consultants' services. However, only the Commission's October 9, 2023 order includes itemized invoices supporting the charges incurred.

Kentucky Power has paid each invoice in full. Nonetheless, it is Kentucky Power's ordinary business practice to require the itemization of these kinds of charges from vendors providing goods or services to Kentucky Power. Kentucky Power therefore believes it would not be unreasonable for such detail to be provided to support the consultant charges that Kentucky Power is required to pay as part of this proceeding.

WHEREFORE, Kentucky Power Company respectfully requests the Commission enter an Order:

- 1. Supplementing the record of this case with the itemized invoices supporting the costs charged by the consultants and other advisors retained by the Commission in this case pursuant to Kentucky's securitization statute, KRS 278.674(3); and
 - 2. Granting Kentucky Power all further relief to which it may be entitled.
