## **NOTICE OF PUBLIC HEARING**

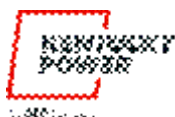

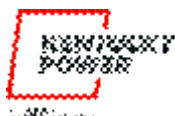

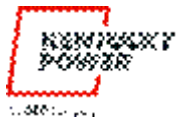
