JOINT MOTION OF KENTUCKY UTILITIES COMPANY AND TIMOTHY AND PATRICIA BROWN TO HOLD PROCEEDING IN ABEYANCE

The Respondent, Kentucky Utilities Company (“KU”), and the Complainants, Timothy and Patricia Brown, jointly move the Kentucky Public Service Commission (“Commission”) to hold these proceedings in abeyance for sixty (60) days. The parties and their counsel met on August 18, 2023 to discuss this case and related issues. They are continuing to work towards an agreeable resolution, and both parties commit to filing an update with the Commission on or before October 20, 2023, reporting whether the parties have reached an agreement.


The parties also agree to toll the Complainants’ time in which to respond to KU’s Motion to Dismiss. Should the parties be unable to reach a satisfactory resolution by October 20, 2023, the parties agree that Complainants would have seven (7) days, after the date on which the parties inform the Commission of the impasse, to file their Response to KU’s Motion to Dismiss. Should the Commission deny this Joint Motion to Hold the Proceeding in Abeyance, the parties

agree that Complainants would have seven (7) days, following the date of the Commission's order denying this joint motion, in which to file their response to KU's Motion to Dismiss.

WHEREFORE, Kentucky Utilities Company and Timothy and Patricia Brown respectfully request that the Commission enter an order holding this proceeding in abeyance until October 20, 2023.


