The Commission has historically removed pension and OPEB costs in excess of the statutorily required contribution amounts from water rates. However, as the wholesale rate to Grayson County Water District was developed with collaboration amongst the two parties, the proposed increase will be allowed to go into effect June 2, 2023. In the future, pension and OPEB costs in excess of the statutorily required contribution amounts should not be included in the determination of the wholesale rate to Grayson County Water District.


While the proposed rates are the rates proposed by Leitchfield Utilities, the Public Service Commission may order rates that differ from these proposed rates.

**Resolution of Grayson County Water District Board of Commissioners
Adopting the Proposed Rates**

**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF
GRAYSON COUNTY WATER DISTRICT ADJUSTING WATER
RATES AND CHARGES TO OFFSET THE WHOLESALE RATE
INCREASE OF THE LEITCHFIELD UTILITIES COMMISSION**

WHEREAS, Grayson County Water District (“the District”) is a water district organized pursuant to KRS Chapter 74;

WHEREAS, the Leitchfield Utilities Commission (“Leitchfield”) is a wholesale water supplier of the District;

WHEREAS, Leitchfield provides wholesale water service to the District pursuant to a water purchase contract executed on August 21, 1972, and subsequently amended several times, the most recent being April 8, 2008;

WHEREAS, pursuant to the terms of the water purchase contract as amended, Leitchfield and the District have established a process for periodic adjustments of Leitchfield’s rate for wholesale water service;

WHEREAS, pursuant to that agreed process, Leitchfield and the District have determined that Leitchfield’s rate for wholesale water service to the District should be adjusted to \$3.337 per 1,000 gallons;

WHEREAS, on May 2, 2023, Leitchfield filed notice with the Kentucky Public Service Commission that, effective June 2, 2023, its rate for wholesale water service to the District would increase to \$3.337 per 1,000 gallons;

WHEREAS, based upon its water purchases from Leitchfield for the period from April 19, 2022 to April 20, 2023, the District’s annual purchased water costs will increase approximately **\$167,480.83** once Leitchfield’s wholesale rate is effective;

WHEREAS, to generate the increased annual purchased water costs resulting from the increase in Leitchfield’s wholesale rate, each tier of each meter size of the District’s existing rate schedule must be increased \$0.43 per 1,000 gallons (“purchased water adjustment factor”);

WHEREAS, prudent financial management dictates that the District take immediate action to adjust its retail rates commensurate with Leitchfield’s wholesale rate increase; and

WHEREAS, KRS 278.015 permits a water district to adjust its rates commensurate with an adjustment in the rate of the water district’s wholesale supplier without the prior approval of the Kentucky Public Service Commission.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF COMMISSIONERS OF GRAYSON COUNTY WATER DISTRICT AS FOLLOWS:

Section 1. The facts, recitals, and statements contained in the foregoing preamble of this Resolution are true and correct and are hereby affirmed and incorporated as a part of this Resolution.

Section 2. The purchased water factor is **\$0.43 per 1,000 gallons;**

Section 3. Each tier of each meter size of the District's existing tariff shall be increased by **\$0.43 per 1,000 gallons**, effective June 10, 2023, subject to any minor adjustment that may be made by the Kentucky Public Service Commission.

Section 4. The monthly water rates to be charged to and collected from the customers and users of the District's water system shall be as set forth in **Appendix A**, which is attached hereto and is incorporated herein by reference as a part of this Resolution. These monthly rates and charges shall be in effect for all water service rendered on and after June 10, 2023.

Section 5. Should the Kentucky Public Service Commission suspend Leitchfield's proposed wholesale rate for further review, then the rates set forth in Appendix A shall not take effect and the District's present rates shall remain in effect until further action by this Board.

Section 6. If the Kentucky Public Service Commission allows the proposed wholesale rate to take effect, the Chair is hereby authorized and directed to execute and file all documents necessary to comply with KRS 278.015 and 807 KAR 5:068.


Section 7. This Resolution shall take effect upon its adoption.



COMPLIANCE WITH 807 KAR 5:068, SECTION 5

Pursuant to 807 KAR 5:068, Section 5(1), the attached notice was posted at Grayson County Water District's offices on or before June 9, 2023, and will be posted on Grayson County Water District's website no later than June 16, 2023. The notice will be published once in the *Grayson County News*, a newspaper of general circulation in Grayson County Water District's service area no later than the issuance of the first bill at the increased rate.

NOTICE

On June 2, 2023, the Leitchfield Utilities Commission increased its wholesale water service rate to Grayson County Water District from \$2.375 per 1,000 gallons to \$3.337 per 1,000 gallons. On June 10, 2023 Grayson Water District will adjusted its rates by \$0.43 per 1,000 gallons to reflect the increase in its cost of purchased water due to the increase in the Leitchfield Utilities Commission’s rate for wholesale water service. On June 12, 2023, Grayson County Water District applied to the Public Service Commission for approval of the rates set forth below.
