MOTION TO SUBMIT

Comes now East Kentucky Power Cooperative, Inc. ("EKPC"), by and through counsel, pursuant to the July 31, 2023 Order ("July 31st Order") of the Kentucky Public Service Commission ("Commission") other applicable law, and for its Motion to Submit this case for an adjudication based upon the existing administrative record and without a formal evidentiary hearing, respectfully states as follows:

The Commission's July 31st Order set forth the procedural schedule for this proceeding. The Commission issued its initial set of information requests on August 15, 2023, which were answered by EKPC on August 29, 2023. The Commission issued supplemental requests for information on September 11, 2023 to which EKPC provided responses on September 26, 2023. EKPC filed its initial Motion to Submit on October 6, 2023. Following that filing, Commission Staff entered a thirst set of requests for information on the same day, October 6, 2023. EKPC filed its responses on October 18, 2023 and supplemental testimony on October 19, 2023. There are no intervenors in this proceeding and the remainder of the items contained in the procedural schedule pertain to intervenors. The July 31st Order allows EKPC to request or waive a hearing on or before November 14, 2023. EKPC believes that the issues presented in this case are straightforward and have been adequately addressed through the written discovery and the Motion for Confidential Treatment that was filed contemporaneous with EKPC's responses. The interests of administrative economy favor avoiding a formal hearing when it would be unlikely to result in the development of any additional facts. Moreover, EKPC is unaware of any contested issues for which clarification might be necessary or advisable. Accordingly, EKPC does not believe that a formal evidentiary hearing is necessary in this case and moves to submit the case for an adjudication based upon the existing administrative record without a formal evidentiary hearing. Further, EKPC incorporates its October 6, 2023 Motion to Submit herein and files this in supplement based upon the additional evidence filed into the record. Alternatively, should the Commission determine that a hearing is necessary, EKPC will be happy to participate.

WHEREFORE, on the basis of the foregoing, EKPC respectfully moves to submit this case for an adjudication based upon the existing administrative record and without a formal evidentiary hearing.
