On behalf of Louisville Water Company, thank you for attending the meeting of our wholesale customers held on March 7, 2023. We hope you found the information we shared beneficial.

As previously discussed at the above meeting, the proposed wholesale commodity charge effective July 1, 2023 will be \$2.13 per thousand gallons, plus an elevated service area surcharge of \$0.50 per thousand gallons, for a total wholesale rate of \$2.63 per thousand gallons. This represents a 3.1% increase of the current rate.

We are planning to file the necessary documentation for this proposed new rate with the Public Service Commission (PSC) near the end of March. RESOLUTION NO. 2023-05-01

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE NORTH NELSON WATER DISTRICT ADJUSTING WATER RATES AND CHARGES TO OFFSET THE LOUISVILLE WATER COMPANY AND THE CITY OF BARDSTOWN WHOLESALE RATE INCREASES

WHEREAS, the Louisville Water Company ("LWC") and the City of Bardstown ("Bardstown") are North Nelson Water District's ("District") wholesale water providers;

WHEREAS, on March 30, 2023 LWC filed an application with the Kentucky Public Service Commission ("PSC") seeking to increase the wholesale water rate that LWC charges the District from \$2.55 to \$2.63 per 1,000 gallons and seeking to increase the monthly meter fees that LWC charges the District (See PSC Case TFS2023-00168), effective July 1, 2023;

WHEREAS, on November 15, 2019 Bardstown filed an application with the PSC seeking to increase the wholesale water rate that Bardstown charges the District. Bardstown's application requested multiple step increases staring on July 1, 2020 and continuing each July 1 until July 1, 2023. The PSC approved Bardstown's application on January 1, 2020 (See PSC Case TFS2019-

00625). Effective July 1, 2022, Bardstown's wholesale rate will increase from \$2.64 per 1,000 gallons to \$2.72 per 1,000 gallons;

WHEREAS, based upon the water purchases from LWC and Bardstown during the previous 12 months, the estimated annual increased cost to the District will be \$24,670.16;

WHEREAS, prudent financial management dictates that the District take immediate action to adjust its retail rates commensurate with LWC's and Bardstown's wholesale rate increases; and

WHEREAS, KRS 278.015 and 807 KAR 5:068 provide the legal mechanism for the District to increase its water rates commensurate with LWC's and Bardstown's wholesale rate increases via a Purchased Water Adjustment ("PWA").

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF COMMISSIONERS OF NORTH NELSON WATER DISTRICT AS FOLLOWS:

Section 1. The facts, recitals, and statements contained in the foregoing preamble of this Resolution are true and correct and are hereby affirmed and incorporated as a part of this Resolution.

Section 2. The PWA factor is \$0.10 per 1,000 gallons;

Section 3. All tiers of water usage set forth in the District's existing tariff shall be increased by \$0.10 per 1,000 gallons, subject to any minor adjustment that may be made by the PSC.

Section 4. The monthly water rates to be charged to and collected from the customers and users of the water system of the District shall be as set forth in Appendix A, which is attached hereto and is incorporated herein by reference as a part of this Resolution. The rates and charges set forth in Appendix A are subject to any minor adjustment that may be made by the PSC. These monthly rates and charges shall be in effect for all water service rendered on and after July 1, 2023.

Section 5. The General Manager is hereby authorized and directed to execute and file the PWA Application, Tariff Sheet, and all other documents that may be required by the PSC.

Section 6. The General Manager, all appropriate District Staff, and the District's attorney are hereby further authorized and directed to take any and all other actions and to execute and deliver any and all other documents as may be reasonably necessary to implement the PWA.

Section 7. This Resolution shall take effect upon its adoption.
