



The Public Service Commission of Kentucky will hold a hearing beginning on Monday, December 11, 2023, at 9:00 a.m., Eastern Standard Time, for the purpose of cross-examination of witnesses in Case No. 2023-00191, which is the Electronic Application of Kentucky-American Water Company for an Adjustment of Rates, a Certificate of Public Convenience and Necessity for Installation of Advanced Metering Infrastructure, Approval of Regulatory and Accounting Treatments, and Tariff Revisions. This hearing will be streamed live and may be viewed on the PSC website, [psc.ky.gov](http://psc.ky.gov). Public comments may be made at the beginning of the hearing.
