## **ANNUAL COST OF OPERATION FOR AMI**

Kentucky-American Water Company ("KAW"), in response to the Commission's July 7, 2023 Correspondence, states as follows. The Commission's Correspondence indicates that KAW did not provide the estimated annual cost of operation after the proposed facilities are placed into service as required by 807 KAR 5:001, Section 15(2)(f). KAW respectfully submits that it fully complied with the regulation. Paragraph 28 of the Application provides the forecast annual cost of operation at year 10, which is the first year the infrastructure that is the subject of the CPCN will be fully deployed and placed in service. This is akin to the first year a pipeline is placed in service. Paragraph 28 also provides the forecasted annual cost of operation at year 20. KAW thus provided the annual cost of operation for two calendar periods in its Application and requests the Commission to deem the Application filed as of June 30, 2023.

In the event the Commission does not find the Application sufficient as of June 30, 2023, KAW is providing below the estimated forecast annual cost of operation, as well as the estimated forecast annual cost net of benefits, for each year from 2024 to 2043.

The annual costs of operations are comprised of (1) depreciation; (2) property tax; (3) pretax rate of return and (4) revenue taxes. The benefits are comprised of (1) meter reading expenses; (2) service order expense; and (3) vehicle fleet, fuel, and maintenance.

WHEREFORE, KAW respectfully requests the Commission deem its Application filed as of June 30, 2023. KAW alternatively requests the Commission deem the Application filed as of today, July 7, 2023.
