**ATTORNEY GENERAL AND LEXINGTON-FAYETTE URBAN COUNTY  
GOVERNMENT’S JOINT RECOMMENDATION TO SUBMIT ON THE RECORD FOR  
A FINAL DECISION ON REHEARING**

The intervenors in this proceeding, the Attorney General of the Commonwealth of Kentucky, through his Office of Rate Intervention (“Attorney General”), and Lexington-Fayette Urban County Government (“LFUCG”), by counsel, hereby submit their recommendation regarding submission of this case for a final decision on their May 21, 2024 joint petition for rehearing as well as Kentucky-American Water Company’s (“Kentucky American”) May 16, 2024 petition for rehearing. Pursuant to the Commission’s May 28, 2024 Order in this matter, the parties are required by July 26, 2024, to either request a hearing or state whether the case can be submitted on the existing record. The Attorney General and LFUCG recommend that both of the aforementioned petitions for rehearing be submitted on the record for a final decision in the pending case. However, if the Commission determines that a public hearing is necessary, then the Attorney General and LFUCG will fully participate in the hearing.
